The shares of Chongqing Gas are listed on the Shanghai Stock Exchange. As of the date of this announcement, Chongqing Gas is indirectly owned as to 39.43% by China Resources Gas Group Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) and is a subsidiary of the Company.
